

COLUMBIA SHUSWAP REGIONAL DISTRICT

BYLAW NO. 5724

A bylaw to establish a service area within Electoral Area 'F' of the Columbia Shuswap Regional District for the purpose of operation and ownership of a water system for the Lee Creek area.

WHEREAS a regional district may, by bylaw, establish and operate a service under the provisions of the Local Government Act;

AND WHEREAS the Board of the Columbia Shuswap Regional District wishes to establish a service within Electoral Area 'F' for the purpose of operation of a water system in the Lee Creek area within Electoral Area 'F';

AND WHEREAS the Board has submitted the proposal to establish the service to the electors within Electoral Area 'F' and approval of the electors, pursuant to the Local Government Act, has been obtained;

AND WHEREAS the Director for Electoral Area 'F' has consented, in writing, to the adoption of this bylaw;

NOW THEREFORE the Board of the Columbia Shuswap Regional District, in open meeting assembled, HEREBY ENACTS as follows:

SERVICE

1. To establish within Electoral Area 'F' a service area to be known as the "Cottonwood Waterworks Service Area".

SERVICE AREA

2. The service area established by this bylaw is shown as outlined on Schedule 'A' attached hereto and forming part of this bylaw.

PARTICIPATING AREA

3. The participating area in the named service is a portion of Electoral Area 'F'.

REQUISITION

4. The maximum amount of money that may be requisitioned for the service provided under Section 1 of this bylaw will be Two Hundred Thousand Dollars (\$200,000) annually.

COST RECOVERY

- 5. The annual operating and debt servicing costs shall be recovered by one or more of the following:
 - a) The requisition of money to be collected by a parcel tax;
 - b) The imposition of fees and other charges that may be fixed by separate bylaw for the purpose of recovering these costs;
 - c) Revenues received by way of agreement, enterprise, gift, grant or otherwise.

FORCE AND EFFECT

6. This bylaw will come into force and effect upon adoption.

CITATION

7. This bylaw may be cited as "Cottonwood Waterworks Service Area Bylaw No. 5724"


