

## COLUMBIA SHUSWAP REGIONAL DISTRICT

### BYLAW NO. 5615

#### A bylaw to require that waste and recyclables be disposed of at authorized facilities only

WHEREAS the Board of the Columbia Shuswap Regional District wishes to require that waste and recyclables only be disposed of within the Regional District at certain authorized facilities;

NOW THEREFORE the Board of the Columbia Shuswap Regional District, in open meeting assembled, HEREBY ENACTS as follows:

#### **DEFINITIONS**

“**Authorized Facility**” means a Refuse disposal facility or Refuse transfer station in either case operated by or on behalf of the Regional District or a municipality within the Regional District or a facility that is permitted to accept Refuse (including for recycling purposes) by the Regional District or under the *Environmental Management Act* (British Columbia).

“**Refuse**” means discarded or abandoned materials, substances or objects, including, but not limited to: solid wastes such as unmarketable food wastes; market wastes such as fruit and vegetables; combustibles such as leather, wood and unmarketable paper; non-combustibles such as crockery, unmarketable glass, dirt, ashes from fireplaces and on-site incinerators, street sweepings; bulky wastes furniture, un-usable construction and demolition refuse such as non-metal pipe and plastics.

“**Regional District**” means the Columbia Shuswap Regional District.

#### **ILLEGAL DUMPING**

1. No person may deposit or dispose of Refuse within the boundaries of the Regional District other than at an Authorized Facility or in a container scheduled for collection and delivery to an Authorized Facility.

#### **VIOLATIONS & PENALTIES**

2. Every person who violates any provision of this bylaw, or who permits or allows any act or thing to be done in contravention of this bylaw, commits an offence.
3. A person who violates a provision of this bylaw, or who consents, allows or permits any act or thing to be done in violation of a provision of this Bylaw, commits a separate offence for each day that the violation continues.

- 4. Without limiting the Regional District's powers to enforce this bylaw, an information may be laid by means of a ticket for a contravention of this bylaw if this bylaw is designated as a ticketable offence pursuant to "CSRD Ticket Information Utilization Bylaw No. 5296" and amendments thereto.




